Treasurer Debby Dearden presented the following Motion which was seconded by Director Joe Grandy:

<u>MOTION:</u> Approval of the March 15, 2005 and March 22, 2007 Minutes as presented. Upon vote, unanimously approved.

## **Approval of Financial Report:**

Financial statements for the period ending 03/24/2007 were presented in the Board Pack by NW Community Management.
